NOTICE OF RACE

1 Organising Authority

- 1.1 The Organising Authority (OA) is Rush Sailing Club (RSC) in association with the Irish International 420 Class Association.

2 Rules

- 2.1 Racing will be governed by the 'rules' as defined in the Racing Rules of Sailing (RRS) and the ISA prescriptions to them. This Notice of Race may be amended by the OA, and in any conflict with a Sailing Instruction, the Sailing Instruction shall prevail.
- 2.2 Helms may not change crews during the event without prior permission of the OA.
- 2.3 Equipment (i.e. foils, spars, sails) shall not be changed between races except in the case of damage and then only with the written approval of the Race Officer. In such cases the damaged equipment may be inspected by the class Scrutineer for the event.
- 2.4 Parent/Guardian Declarations: All helms and crews who are under 18 years of age must submit declarations signed by their parent or guardian with their entry form or at event registration.
- 2.5 Where there is a conflict with the Notice of Race, the sailing instructions shall prevail, except that neither shall change nor alter a class rule
- 2.6 Advertising
Boats may be required to display advertising chosen and supplied by the OA

3 Eligibility

- 3.1 Entry is open to all International 420 Class dinghies, sailed by helms and crews who are members of their National 420 Class Association and are also members of their National Authority (e.g. ISA) or an affiliated club.
- 3.2 At regatta registration, competitors will be required to show a valid measurement certificate for their boat, and evidence of membership of their class association.

4 Entries

- 4.1 Eligible boats may enter online at www.sail420.com/
- 4.2 Late entries will be accepted on the day but is preferable that entries are received before the event.
- 4.3 The entry charge of €120 will apply for entries made before midnight 21st August midnight, after which entry fee will be €150. The entry fee is non-refundable.
- 4.4 To comply with registration requirements, competitors must ensure the following:
 - a) *An online entry has been made on the irish 420 website*
 - b) *Emergency contact names and telephone numbers are provided*
 - c) *Completion of safety checks as required*
 - d) *Completion of Parental Consent Form for U18's sailors*

5 Event Schedule

- 5.1 Competitors shall register with the Race Office on the first day of the event from 08:45 to 10:00.
 - 5.2 The warning signal for the first race each day will not be made before 11:25 on Friday and 10:55 on Saturday and Sunday. It is intended that no warning signal will be made after 16h30 on Sunday 6th August, except for Postponements and general recalls of a race where the warning signal was made before 16h 30.
 - 5.3 The target time for each race will be approximately 45 minutes for the leading boat.
 - 5.4 The Championship will consist of 9 races.
 - Three races on Friday 26th August
 - Three races on Saturday 27th August
 - Three races on Sunday 28th August
- However, the race committee may run one additional race each day to pick up lost races or anticipated lost races.
- 5.5 A Briefing will be held next to the race office at 10:00 on Friday 28th August. The race area will be advised during the briefing.

6 Statement of Liability

- 6.1 It is the Competitor's decision to enter the Regatta or to start in any race. Competitors shall accept that their participation in the Regatta is at their sole, exclusive risk, in every respect. By way of entry to the Regatta, competitors shall indemnify the Irish 420 Class Association, Rush Sailing Club, their officers, members, servants and agents in respect of all claims and demands of whatever nature which may be made upon them in connection with or howsoever arising from their participation or intended participation in the Regatta. Competitors shall acknowledge that the Irish 420 Class Association, Rush Sailing Club, their officers, members, servants and agents accept no responsibility in respect of loss of life, personal injury or loss or damage to property which may be sustained by reason of their participation or intended participation in the Regatta or howsoever arising in connection with these events.

7 Insurance

- 7.1 Boats are required to sign a declaration to the effect that they are adequately insured for the duration of the event, including insurance against third party claims of at least €2.5 Million or the equivalent in other currencies. All owners / competitors who sign the entry forms are deemed to have made a declaration that they hold such cover. Owners/competitors not holding this cover shall withdraw their entry.

8 Sailing Instructions

- 8.1 The Sailing Instructions for the event will be available at registration and may be placed on the 420 website and Rush Sailing Club website in advance of the event.

9 Safety Regulations

- 9.1 Life-jackets or other adequate personal buoyancy shall be worn by all competitors at all times whilst afloat. Wet suits and dry suits are not adequate personal buoyancy. All boats must have an appropriate tow line, taped to the deck in accordance to International 420 Class rules.

10 Radio Communication

Except in an emergency, a boat shall neither make or receive radio transmissions while racing.

11 Scoring

- 11.1 The low points scoring system of RRS Appendix A, will apply.
11.2 Three races will constitute a series in the event.
11.3 There will one discard if 4 to 7 races are sailed and two discards if 8 races are sailed.

12 Private or Team Support Boats

- 12.1 Support boats shall register at the Race Office during the registration period. During racing support boats shall remain more than 100 metres from the course area, except when asked to assist by the Race Committee.

13 Event Prizes

- 13.1 The OA will publish details of the prizes prior to the event.

14 Food

- 14.1 There will be a bbq on Saturday after sailing for all competitors. Tickets must be purchased on Friday morning at registration.

15 Ferries, Accommodation and Camping

- 15.1 Local accommodation is available. There are several b&b's both in Rush and in the surrounding areas. There is also a few hotels within 30min drive of the club.
- 15.2 There will also be a designated area for camping in tents. Grass area is limited and air mattresses are recommended. We also have a limited number of spaces for camper vans. Please contact David Kelly on 0892554524 to reserve both your space for tents or camper vans.
